*Food Vendor Agreement – Spring Hope Pumpkin Festival*

The Spring Hope area Chamber of Commerce, herein referred to as “Lessor” and the exhibitor, herein after referred to as “Lessee”, agree to the following:

Lessor agrees to furnish space (24 feet in length by 10 feet in width) for a rental fee of \$ 325.00 due by the **deadline of August 15, 2010**. This fee includes space rental and vendor street fair permit.

**All FEES are NON-REFUNDABLE.**

Lessee must submit a menu price list including items that will be sold with application in order for the application to be processed by the Lessor. Prices can not be increased during the named event or Lessee will be required to leave immediately – with no refund. **NO EXCEPTIONS**. Additionally, a photo of the vehicle, booth, set/up and a complete description is required before application will be processed. This should be submitted with application.

*Lessee agrees to state clearly on the application the power needs of volts, amps, and type of hookup (plug in or wire in), linear footage of booth including tongue, extended awnings, and serving location of tongue, whether to left, right or rear of tongue. Lessee agrees to supply at least 100 ft or more of power cable. Application will not be processed without this information.*

Lessee agrees to submit the completed Food Vendor application and space rental fees paid in full to Lessor by the deadline. Spaces are available on a first come, first serve basis and the same space is not guaranteed from year to year. Lessor will be notified if their application has been accepted bearing that all appropriate information as been provided to the Lessee.

Lessee will have their space occupied and set up no later than 8:00 pm on Thursday, September 30, 2010. Inspections by the Nash County Health Department will be Friday morning, October 1, 2010. Lessee agrees to keep the food booth operating until 5:00 pm on Saturday, October 2, 2010 unless released earlier by Lessor.

Lessee acknowledges that there are specific health codes for outdoor food vendors and those regulations must be met before vendors will be allowed to serve the public. Lessee also acknowledges if the inspection performed by the Nash County Health Department doesn't meet those standards the Lessee will not be allowed to sell or prepare food from their rental space. Lessee will be required to leave immediately **with no refund**.

***Note: It is the Lessee's responsibility to contact Robert Hunt of the Nash County Health Department at (252) 459-1312 between the hours of 8am-9am and 4:30-5:00pm (Monday-Friday) to obtain all health code requirements and food inspection applications.***

Lessor shall not be responsible for any loss or injury to the Lessee, his/her employees, goods, or customers or for the negligent acts of Lessee while premises are occupied under this agreement.

Lessee agrees to exhibit and sell only the items approved by the Chamber of Commerce through approval of this application and agrees to leave the rental space at the request of the Lessor if deemed necessary by the Lessor with no refund. Lessee is required to see at least one item containing pumpkin or to decorate with a pumpkin theme. **This is required and not optional.**
